Here is the first issue of the *Communicator* for 2014-2015. Please read it carefully and keep it for future reference. This particular issue has all materials needed to participate in drama activities for the first semester. *If you have not been involved with the drama events in the past, please consider doing so. It is a lot of fun and reaps many rewards.* 

At the July meeting of the Executive Board many actions were adopted that affect PHSSL's operation. A number of them were made in response to feedback that the Board received from members. Let me provide you with "headlines." You can find the details within the Meeting Minutes of this mailing. Changes in the Bylaws or Handbooks are ALWAYS updated on the on-line version and available immediately for your convenience. If you do not have access to the internet, please feel free to request paper copies from the State Office.

- 1. Ms. Lisa Bompiani-Smith, Ms. Kate O'Halloran, and Ms. Beth Young were re-elected to the Executive Board. Mr. Nathan Lawver was also elected to the Executive Board this year.
- 2. The technology policy has been revised by the Board to reflect advancements in today's digital environment and aid in improving skills of students in preparation and delivery of speeches.
- 3. Changes have been made in the format and scheduling of Radio Announcing at the State Tournament.
- 4. There were other changes made in regards to the format and scheduling for the State Tournament in an effort to conclude events at an earlier time on Friday evenings, to provide more on-site food options for participants, to help eliminate confusion with judging assignments, and to promote more fluidity during the two day event.
- 5. Surveys were sent to PHSSL membership to collect feedback regarding Parliamentary and Policy debate. Based on feedback, a number of changes were made in regards to both events, as well as to other areas of debate, and will be implemented for the 2014-2015 school year.
- 6. Certificates will be available on the PHSSL website for chairs to print and provide to alternates at regional competitions, if they so choose.
- Susquehanna University is pleased and able to offer Act 48 credits to public school teachers for participating in (1) PSDA Convention and (2) PHSSL State Tournament.
- 8. Please be sure to forward information to the State Office regarding any PHSSL competition you have scheduled, so we can place it on the Events Calendar.
- 9. Hall of Fame Coordinator: Mr. David Long. Please send your nominations no later than December 1.
- 10. Again for 2014-2015, Student Congress Bills/Resolutions are to be submitted to Alice Ursin no later than January 21. All Congress Bills/Resolutions are to be sent electronically as a word document to **Ms. Ursin** who will determine if they fit the format. (Email as a Microsoft Word Document to **ajursin@yahoo.com**.) **January 1** is the first day to submit, and **January 21** is the last day to submit Congress Bills/Resolutions to Ms. Ursin. They are to be submitted to Ms. Ursin by the Forensic Coach, **not** student competitors. The bills will be posted on the PHSSL website prior to the State Tournament for each team to obtain in preparation for competition. An email will be sent to the forensic director of participating teams explaining how to access bills for Student Congress House and Senate events.

As I said earlier, the above reflects PHSSL **"headlines."** The minutes of the meeting detail the actions and discussions about the above, as well as other information for you to be aware of. You will find a copy of the Minutes in the September *Communicator*. If I can help you in any way during the year, please let me know, and we will do whatever we can to help you. #### Pennsylvania High School Speech League Summer Executive Board Meeting July 12, 2014

In Attendance: Keith Brosious, John Buettler, Barbara Giuliano, David Long, Michael Nailor, Kate O'Halloran, Beth Young, Larry Augustine-Executive Director, and Codie Nevil Sauers- State Secretary Excused: Lisa Bompiani-Smith, Ellen Boyer, Lorinda Krause, Nathan Lawver, Hugh Ringer, Neil Strine and Sharon Volpe

CALL TO ORDER: The meeting was called to order at 12:30 PM by Ex. Dir., Larry Augustine.

**APPROVAL OF MINUTES**: The Minutes from the March 27, 2014 meeting were approved. Motion by Mr. Buettler. Seconded by Ms. Giuliano. Passed unanimously.

#### ADDITIONS/MODIFICATIONS TO AGENDA:

- 1. Electronic Voting by Board members (Nailor)
- 2. Add a specific section for Parliamentary and Policy Debate after Radio Announcing (Nailor)
- 3. Use of judges (Young)

#### EARLY ANNOUNCEMENTS:

1. 2014-2015 Elected Executive Board members: Returning; Lisa Bompiani-Smith, Kathleen O'Halloran, Beth Young. Newly elected; Nathan Lawver. Election statistics: 148 ballots sent out and 41 returned, which accounts for 28% of member schools. This was a decrease of 4% from last year.

- 2. 2014 Drama Festival dates: December 5-6.
- 3. 2015 State Tournament: March 20-21.

#### **DIRECTOR'S REPORT**:

Financial reports were presented for the fiscal year:

 Profit & Loss Summary—Profit & Loss Detail—Check Detail—Balance Sheet—Transaction Sheet PHSSL saw a net income this fiscal year of \$5,536.72. The organization also saw an increase in members for the year, as well as an increase in the number of schools and students that participated at the State Tournament.

Mr. Long moved to accept the reports. Seconded by Ms. Young. Passed unanimously.

#### **COMMITTEE REPORTS**:

1. There are no Committee Reports to present at this year's meeting.

#### NEW BUSINESS:

1. Administrative

A. A new brochure and the proposed calendar for 2014-2015 were reviewed. Minor changes to be made regarding address changes. The Board was reminded to pass along to coaches, the Calendar of Events Submission Form to have events added to the PHSSL calendar.

A motion to accept the calendar was made by Mr. Long. Seconded by Mr. Buettler. Passed unanimously.

B. District assignments were reviewed and assigned for elected Board members. District Chair and Regional Coordinator assignments were reviewed. Michael Shaffer was added as a co-chair to District 3 with Alice Ursin. All other District Chair and Regional Drama Coordinator assignments remain the same as last year. District assignments for Board members are as follows: Lisa Bompiani-Smith (District 7), Ellen Boyer (District 15), Keith Brosious (District 9), John Buettler (District 11), Barbara Giuliano (District 12), Nathan Lawver Districts 6 & 8), David Long (District 10), Michael Nailor (Districts 5 & 14), Kathleen O'Halloran (District 3), Hugh Ringer (District 2), Sharon Volpe (District 4), Beth Young (District 1)

C. David Long will continue to serve as Hall of Fame coordinator.

D. A motion was made by Ms. Young to develop a separate drama brochure and distribute it to high school drama directors. Seconded by John Buettler. Passed unanimously. The Board also accepted the Drama Festival Information Sheet. The sheet will be reviewed with two current drama coordinators and then posted on the PHSSL website.

#### 2. General

A. **Certificates**: There was a discussion concerning what certificates should or should not be provided for competitors at district tournaments. The Board agreed the current system will continue where the state office sends certificates to district chairs to be awarded for qualifying competitors. However, a template will be made for those competitors who place as alternates and will be made available on the PHSSL website. District chairs will be able to access the template at any time to print alternate certificates if they choose to award them at their district tournaments.

B. **Interpretation of serial literature**: After discussion, the Board decided to provide an example to clarify a "single source" for purposes of PHSSL competition. A motion was made by Mr. Long to add the following statement to the PHSSL Bylaws B12.3, B13.3, and B14.3:

"A cutting of *Modern Family* would be one source. However, a cutting of an episode of *Saturday Night Live* involving three different skits would not be a single source".

Seconded by Mr. Nailor. Passed unanimously.

C. **Technology policy**: After discussion, a decision was made to replace the current policy with the following statement:

Being able to collect and organize current data is an important skill in today's digital environment. We believe that having the opportunity to use digital resources and synthesize information taken from them to make the best speeches and arguments possible will provide practice in a valuable skill that cannot be matched in any other academic situation.

The use of electronic retrieval devices is permitted in all PHSSL events. This ruling is not meant to imply that any student must use electronic devices, merely that it is now permitted.

• This includes the retrieval -- in preparation rooms and during rounds -- of stored data and, if possible, the online retrieval of current information.

- This includes using digital resources to flow debates and to prepare speeches.
- This includes using digital resources to time debates and speeches.

No guarantee of power or of Internet connectivity should be presumed. There should be no expectation placed on host schools to provide either of these resources. Students wishing to use digital devices must be responsible for providing these resources and for having an alternative plan if the digital devices fail.

Digital communication between speakers and persons outside of the competition event or room is not permitted. PHSSL's intent is similar to its rules under Cross-Exam Debate and under the Preparation Room Procedures for Extemporaneous Speaking and Commentary: consulting with a coach or anyone outside the competition room once the competition has begun will result in disqualification from the competition.

This statement will be updated in sections D27 and S25 of the Standing Rules of District and State, and on the Documents/Forms page of the PHSSL website. Motion by Mr. Nailor. Seconded by Ms. Giuliano. Passed unanimously.

D. **Substitutions for a debate team**: The Board considered both pros and cons regarding making substitutions on a debate team if one of the qualified students is not able to attend the state tournament. The Board took no action.

E. **Electronic Voting**: Mr. Nailor suggested the Board add a formal policy to the PHSSL Constitution outlining the ability to vote on Board motions via email. The suggested policy reads:

"The Executive Director may utilize communication technology to conduct urgent business of the League between meetings. Discussion of items will be conducted through electronic channels. Each Board member shall submit a vote on each motion to the Executive Director. Digital motions and the results electronic votes will be recorded in the minutes of the next regular meeting of the Executive Board and all member schools will be notified via email in a timely manner."

Ms. O'Halloran made a motion that the above statement be added to the PHSSL Constitution under section C6. Seconded by Ms. Giuliano. Passed unanimously.

F. Mr. Long made a motion that the meeting minutes of the summer meeting be emailed to the previous year's membership and published in the upcoming edition of *The Communicator*. Seconded by Ms. Young. Passed unanimously.

#### 3. Congress

A. **Senate Plan Revisions**: Mr. Long made a motion to make changes to the plans in Student Congress: Senate, section D18, and are as follows:

- Plan A: 2-8 competitors
- Plan B: 9-20 competitors
- Plan C: no change.

Seconded by Mr. Nailor. Passed unanimously.

#### B. Congress awards were reviewed for distribution at the State Tournament:

Mr. Long made a motion to revise section B20.12 regarding the Peggy Madden Outstanding Speaker award: A second Peggy Madden Outstanding Speaker award will be given to the first place speaker at the annual State Tournament in Student Congress: Senate. This is in addition to the one awarded to the first place speaker in Student Congress: House. Seconded by Mr. Buettler. Passed unanimously.

#### 4. Radio

A. **Eliminate microphone**: The Board considered eliminating the use of microphones in radio competition. After discussion, the Board decided that no action would be taken.

B. Adding a third judge: The Board considered adding a third judge in the early rounds. After discussion, the Board decided that no action would be taken.

C. **Change in schedule and format for Radio Announcing**: Mr. Buettler proposed an amendment to the Radio Announcing event that would address a number of concerns that were presented by PHSSL membership. After discussion, Ms. O'Halloran made a motion to accept the format and schedule proposed by Mr. Buettler. Seconded by Ms. Giuliano. Passed unanimously.

The schedule and format changes for Radio are as follows:

- 1. In preliminary rounds, rounds will continue to be double-flighted. The same judges will judge each flight.
- 2. Judges will pick up and return ballots at the same place as all other judges and report to their rooms.
- 3. Students in each flight will sit together in the room as in other speech rounds and will hear each other's presentation.
- 4. Judges will fill in students' information or have students fill in their own information.
- 5. Tabulation will be done in the same location as other speech events.
- 6. Time schedule:

#### Friday:

3:30 pm	Radio Announcing assembly immediately following opening General Assembly
	Followed by early dinner/snack break.
4.45	Deviad L flight 4 (severe indexe for beth flights)

4:45 pm Round I, flight 1 (same judges for both flights)

5:30 pm Round I, flight 2

- 6:30 pm Round II, flight 1 (same judges for both flights)
- 7:15 pm Round II, flight 2

#### Saturday:

8:30 am Quarter-final Round (4 rooms needed)

- 10:30 am Semi-finalists announced and report for Prep
- 11:00 am Semi-final Round (2 rooms needed for competition, 1 room for Prep)
- 12:30 pm Finalists announced and report for Prep
- 1:00 pm Final Round (1 room needed for competition, 1 room for Prep)

D. **Radio Announcing and Impromptu Re-ranking**: After discussion, it was determined a semi-final re-rank will be used for tie-breaking as provided for in our rules. A quarter-final re-rank will not be used.

#### 5. Parliamentary Debate

A. A survey was developed and sent out to the PHSSL membership, as PHSSL completed its 5th year of competition in Parliamentary Debate. 38 responses were returned. As a result, a committee will be developed to further evaluate concerns that were brought to the attention of the Board through the survey.

B. The Board did decide to take immediate action on aspects of Parliamentary Debate:

- 6 topic areas for Parliamentary will be developed in advance.
- The State Tournament rounds for Parliamentary will consist of 2 prepared rounds (1 on each side) and 2 extemporaneous rounds.
- Topics will be released in advance. However, the resolution will not be announced until the event begins at the State Tournament.
- The Parliamentary Debate ballot will be changed to read Government/Opposition, instead of Affirmative/Negative.
- Pairing sheets will be published about 15 minutes prior to a round.
- Students will be given 15 minutes to prep in their competition room and will be allowed to use technology devices, if they wish. Judges will announce when to start and stop prep.

Mr. Nailor will incorporate these changes to Section B5 in the Bylaws and the Standing Rules of District Procedure D15, as well as the Parliamentary Debate Guide. Once complete, the changes will be provided to the Board for review and a final vote.

C. The Board discussed making adjustments to the schedule for Parliamentary Debate. Ms. O'Halloran made a motion to move Round 4 to Friday night, and to change the start time for the event to 4:15 pm, and moving the event to

Susquehanna University's campus. Seconded by Mr. Long. Passed unanimously. The Parliamentary rounds, on Friday, will be scheduled to begin as follows:

- Round 1: 4:15pm
- Round 2: 5:15 pm
- Round 3: 6:45 pm

Based on this, both Parliamentary and Lincoln Douglas will be moved to Susquehanna University's campus, and 2 events currently held on campus will be moved to the Selinsgrove Elementary School.

#### 6. Policy Debate

A. A survey was developed and sent out to PHSSL membership regarding Policy/Cross-X Debate. 35 responses were returned. Based on the responses, several items were discussed and actions taken.

B. Scouting: Ms. Young made a motion to remove the following from section B1.6 of the Bylaws: "At no time will scouting be permitted. During the course of the District or State Tournament, a judge sharing with one's own team or any other team, a case flow obtained through judging is a violation of the trust and responsibility required of ethical judges. Failure to abide by these rules will result in disqualification of the offending team from the Tournament."

Seconded by Mr. Buettler. Motion passed.

C. Ms. Young moved that B1.6 be removed from the Bylaws: "Open cross-examination is prohibited." Seconded by Mr. Nailor. Passed unanimously.

D. Ms. Young moved to remove section B1.9 from the Bylaws: "Judges may not reveal decisions." Seconded by Mr. Nailor. Motion failed. Judges will continue to be prohibited from revealing decisions in Policy Debate.

E. Mr. Nailor made a motion to eliminate B1.10 from the Bylaws: "Judges shall not award low point wins." Seconded by Ms. O'Halloran. Motion passed.

F. Mr. Long made a motion to replace B1.10 with the following: "If a judge awards a low point win, the judge must clearly state that it is a low point win with a clear explanation on the ballot as to why." Seconded by Mr. Buettler. Passed unanimously.

#### 7. Other Debate Events

A. Mr. Nailor made a motion to add the following statement to the Standing Rules of District (D3) and State (S20): *"Judges may not reveal decisions in any events."* Seconded by Mr. Long. Motion passed.

B. **Scouting in all Debate events**: Mr. Nailor made a motion to also eliminate the scouting prohibition for all Debate events. This motion covers sections B3.6, B4.6, B5.9, reading:

"At no time will scouting be permitted. During the course of the District or State Tournament, a judge sharing with one's own team or any other team, a case flow obtained through judging is a violation of the trust and responsibility required of ethical judges. Failure to abide by these rules will result in disqualification of the offending debater from the Tournament."

Seconded by Ms. Young. Motion passed.

C. **Communication Statement**: Mr. Nailor made a motion to remove the "communication" statement sticker from the debate ballots and place the statement in the Bylaws making it section B1.1. "Communication" will then be

reflected on each debate ballot by adding it as a component of what is judged on the ballots. (i.e., change "Delivery" to "Communication" on Policy ballot. Seconded by Mr. Long. Passed unanimously.

8. Additional actions taken based on PHSSL Feedback items:

A. **Software program for State Tournament**: There is a possibility that the software Joy of Tournaments and Tabroom use may be combined in the future. Mr. Nailor will create a list of questions and speak both to determine the best use for the State Tournament.

B. **Judges Assembly Room for Elimination Rounds**: During the 2015 State Tournament, Weber Chapel Auditorium will be used for judge assembly during elimination rounds to see if the location works better.

## DRAMA HANDBOOK



**Revised: October, 2012** 

#### Section B18.1

Each school may have one entry in the Regional Drama Festivals. In the case of a single gender school, arrangements may be made with the Regional Drama Coordinator of the event.

#### Section B18.2

Each region shall qualify two plays to the State Drama Festival. If eight schools participate in any Regional Drama Festival, three plays will advance from that Regional Festival to the State Drama Festival. No more than eight schools shall make up a Regional Festival. If more than 24 schools enter the Regional Festival, a fourth Regional Festival will be created.

#### Section B18.3

Material used may be a one-act play, a cutting from a longer play, or an original play. Musicals may not be used. The play must have a minimum of three characters. Characters may not be added or cut from published plays that would be in violation of copyright regulations except with written permission by the publisher and/or author. The play which wins first place in the State Tournament may not be used the following year. Each school is responsible for any royalty obligations.

#### Section B18.4

The playing time shall be not less than 20 minutes nor more than 40 minutes. Each play shall also have up to 10 minutes for setting the stage and up to 5 minutes for striking the stage.

#### Section B18.5

A total of 40 minutes will be available to each play for technical rehearsal, including setting the stage, and striking the stage. The time may be used at the discretion of each school, but may not exceed 40 minutes total.

#### Section B18.6

The host school shall supply a basic lighting plot with a minimum of three general lighting areas and one follow spot. It is suggested that participating schools supply a light, sound, and curtain cue sheet. The host school shall supply a simple set adaptable to the needs of the plays. No school should attempt to transport to the festival complete stage settings. All hand properties, make-up, and costumes shall be provided by the school presenting the play.

#### Section B18.7

Any play that is more than one minute under the minimum or one minute over the maximum in extra playing or technical time is not eligible to receive first place on any individual judge's ballot. This will not affect the selection to the All-State Cast.

#### Section B18.8

- a. The regional and state judging shall be the ranking system as used in all Pennsylvania High School Speech League events.
- b. In addition to the ranking of the plays at the State Drama Festival, the judges will name an All-State Cast of not less than three or more than ten members.
- c. The judges are to be selected by the Regional Coordinators for regional competition, and by the Executive Director for State competition. A panel of three judges must be used at the Regional competition. Regional judges will be paid \$10.00 per play. A panel of five judges must be used at the State competition.

#### Section B18.9

The Director of the contest play will not be allowed backstage during setup, performance, and strike. The Director is permitted in the dressing rooms.

#### Section B18.10

Awards at the State Festival: the top three schools receive plaques (first, second, and third); the remaining schools receive "State Finalist" plaques. Each student selected as a member of the All-State Cast receives a plaque (no fewer than three or more than eight).

#### Section B18.11

Regional Registration will now be sent to the State Office, and after all registrations are received, individual schools will be assigned to a regional competition. Geographic location and equalization of regional competition will be the prime factors in assigning schools. There will be three regions. No more than eight schools can be assigned to a region. If needed, additional region(s) will be created. The registration fee for the regional drama festival shall not exceed \$50.00.

#### Section B18.12

All schools participating in Regional Drama will receive 4 points for participation. All schools participating in State Drama will receive 4 points for participation.

#### Section B18.13

The Drama Handbook shall be considered a part of the Constitution.

#### FESTIVAL AND CONTEST SUGGESTIONS

The Regional Drama Coordinator will schedule its Drama Festival whenever it is convenient for that particular Region, and at any time prior to the deadline set by the League Office. Each member school is permitted to enter a play in a Regional Festival. Each Region shall qualify two plays to the State Festival. Where possible, area colleges might be willing to help with the Regional Festival in providing facilities and judges. A member of the Executive Board will be appointed as liaison to each of the Regional Drama Festivals.

The following suggestions are given for the Regional Coordinator and host schools in planning for the Regional, and State Festival.

- 1. The Regional Drama Coordinator must be active in secondary school drama and/or knowledgeable in drama.
- 2. All deadline dates for the Regional and State Festivals will be enforced.
- 3. The schedule for the performances of the plays can be by an impartial drawing for position; or the plays may be scheduled to facilitate staging and timing by the Regional Coordinator (Regional) and the Executive Director (State).
- 4. The host school or Coordinator will provide a competent stage crew. The participating school may provide its own trained stage crew, if acceptable with host and the school's regulations.
- 5. The host school shall provide competent light and sound technicians who will receive cues from the competing high school student stage managers.
- 6. The host shall provide a timekeeper and such house personnel as necessary to insure a smooth running performance.
- 7. The Coordinator will be responsible for sending all necessary information and reports to the Executive Director immediately at the close of the event.

It is the responsibility of the Coordinator in charge to secure competent judges. The judging will be by a panel of judges. Regional judges will be paid \$10.00 per play. The following committees can function to arrange for the planning and presentations of Drama events:

Regional Festival:	Director of the host school, Regional Coordinator as appointed by the Executive
	Director, and Chairperson of the participating districts

#### State Festival: Executive Director, Executive Committee, and the Regional Directors





The acting, directing and technical aspects of production should all be considered as a whole in the critic's evaluation. Since schools are required to keep the amount of scenery to a minimum, the critic is to evaluate the technical aspects of the play in terms of performer's adaption to and use of stage, lighting, and furniture available. Choice of play should not be a criterion in your ranking; rather, the critic should evaluate how well the play chosen was presented. Critics are necessarily allowed some leeway in appraising the performances. We wish the following factors considered as basic, however:

- 1. Characterization and Interpretation Was there a complete bodily and mental recreation of characters by the actors? Were their reactions to other actors correct and effective? Were the interpretations of the roles believable? Was there sufficient motivation, action, and reaction?
- 2. Voice and Diction Could you hear the actors distinctly? Was there variety of rate and inflection? Was pronunciation and articulation properly done and in keeping with the play?
- 3. **Plot Development** Was the production unified? If a cutting, was it a complete and understandable unit? Did ensemble carry the situation to a suitable climax? Did the characterizations and action advance the plot?
- 4. **Direction** Were the roles appropriately cast? Was the theme or main idea of the play brought out? Was there evidence of effectiveness of the director's influence over mechanics of stage business, balance, proportion, emphasis, placing, grouping, and movement of the players on stage and in creation of mood? Were the time limits observed?
- 5. **<u>Tempo</u>** Was the pace in keeping with the general idea of the play? Was there smoothness, variety, and appropriateness in the movement of the play?
- 6. Make-Up and Costumes Although no extra credit should allowed for unusual or elaborate costuming or make-up, were these reasonably convincing and appropriate for the creation of the illusion?
- 7. **Total Effectiveness** What was the total impression of the production upon you, the critic?
- 8. **Critique** Please continue your comments on the back.

## **NFHS Policy Debate Topic Selection and Ballot**

## Synopsis of Problem Areas and Resolutions for 2015-16

#### PROBLEM AREA I: INCOME INEQUALITY

# Resolved: The United States federal government should increase progressive taxation, the federal minimum wage or regulation of predatory lending to substantially decrease income inequality in the United States.

A central philosophical question among economists pertains to the role of government in promoting economic equality. While this is a timeless issue, it has recently returned to the forefront of our political discourse through the Occupy movements that began in 2011 and more recently as a central focus of President Obama's State of the Union Address in 2014. This proposal looks at specific means by which the federal government can address this issue. Possible affirmative cases include the regulation of predatory lending, increases in the federal minimum wage, and a range of tax-related policies, including but not limited to the following: Earned Income Tax Credit, higher income taxes for wealthy Americans, negative income tax, Social Security taxes, capital gains taxes. Possible negative arguments include a defense of the free market system, impacts on job creation, economic competitiveness and business confidence.

#### PROBLEM AREA II: CRIMINAL JUSTICE

#### Resolved: The United States federal government should significantly reform its nonmilitary criminal procedure in the areas of grand juries, plea bargaining, admissibility of evidence and/or sentencing.

The federal criminal justice system is anchored by federal criminal procedure. Criminal procedure governs the conduct of criminal trials; it is designed to protect society from criminal perpetrators but also to ensure the constitutional rights of suspects and defendants. While criminal procedure includes numerous elements, the four areas highlighted by the resolution are grand juries, plea bargaining, admissibility of evidence and sentencing. Possible affirmative cases include increased access to attorneys during grand jury proceedings, changes in prosecutorial guidelines for plea bargaining, limiting the admissibility of certain types of evidence (such as evidence gathered by drone surveillance) and increased judge discretion in sentencing. Negatives arguments in favor of existing criminal procedures could include efficiency, protection of victims' rights, public safety and facilitating effective law enforcement.

#### **PROBLEM AREA III: IMMIGRATION**

## Resolved: The United States federal government should substantially increase its legal protection of economic migrants in the United States.

Defenders of immigration reform argue that America is a nation of immigrants and that a progressive immigration policy will strengthen the economy and ensure fundamental fairness. Opponents believe that immigrants take jobs from Americans and threaten public safety. The resolution uses the term "economic migrants" in order to create a distinction from "refugees." Economic migrants move from one country to another in order to improve the future prospects for themselves and their families, but they are able to return to their country of origin. Refugees are forced to move to save their lives or their freedom. Examples of possible affirmative cases include the following: Providing a path to citizenship for economic migrants already living in the United States, reversing restrictive state laws such as those in Arizona and Georgia, treating economic refugees from Haiti the same as those from Cuba, passing the DREAM Act, providing health care for immigrant families, more generous provision of work permits for immigrants with special skills in medicine or engineering, providing legal representation for detainees, providing food stamps for impoverished immigrant families, managing the current influx of children crossing the border, among others. Negative positions could focus on the economic and employment harms of increased immigration, increased risk of a terrorist attack, federalism positions and the political implications of immigration reform.

#### PROBLEM AREA IV: SURVEILLANCE

## Resolved: The United States federal government should substantially curtail its domestic surveillance.

The controversy between national security objectives and privacy became a hot one for debate since it was disclosed in June of 2013 by former defense contractor Edward Snowden (supported by journalist and former debater Glenn Greenwald) that the NSA is engaging in extensive surveillance inside the United States in order to fight crime and reduce the threat of The magnitude of the disclosure shocked many people, including elected terrorism. representatives, who were unaware of the extent of the surveillance. Many civil rights advocates view the surveillance as an assault on liberty while law enforcement and national security officials see the programs as essential weapons in the war on terror, the fight against nuclear weapons proliferation and the general protection of U.S. national security. Possible affirmative cases include establishing general probable cause and reasonable suspicion requirements, banning the collection of metadata, restricting the collection of email or chat content, limiting the amount of time that information can be stored for, elimination of Section 215 of the Patriot Act and FISA Court reforms as they apply to the domestic arena. Advantages will focus on privacy, totalitarianism, commerce and racism. Negative positions can focus on terrorism, nuclear proliferation, crime and kritiks of reform-based approaches.

#### **PROBLEM AREA V: INDIAN COUNTRY**

## Resolved: The United States federal government should substantially decrease its authority within Indian Country.

More than five million American Indians and Alaskan Natives reside within the United States – a number constituting 2% of the American population (U.S. Census Bureau, 2011). American Indians and Alaskan Natives live in every state in our union, with 5 U.S. states containing federally recognized tribal reservations or corporations within their boundaries. The links between American Indians and Alaskan Natives and the history of our nation are deeply entwined and the subject of hundreds of thousands, if not millions of pages, of research. This topic will allow affirmative teams to explore the potential benefits of removing federal authority over one or more aspects of life in Indian Country. Possible affirmatives could explore these benefits in one or more areas, including commerce, criminal justice, education, environmental regulation, land use, health and welfare and also the concept of giving Natives total sovereignty. Affirmatives would also be able to explore transitioning from federal to state control, allowing for an exploration of issues like federalism and other state-specific arguments. Negative arguments include disadvantages based on modeling, funding, federalism, rights, sovereignty, movements, funding; critical arguments will include discussions of the image of Native Americans in our society, the concept of federal control, specific language arguments and environmentalism often using literature from native writers. "Indian Country" is a proper legal term used in nearly every legal writing about Native Americans, and a phrase commonly used by tribal councils themselves.
